1. DEALER REGISTRATION COMPLETED IN FULL WITH SIGNATURES OF THE OWNERS AND THEIR REPRESENTATIVES
2. COPY OF - ARTICLES OF INCORPORATION (first and last page)
3. COPY OF - OMVIC VEHICLE DEALER LICENCE AND EACH ANNUAL RENEWAL THEREAFTER
4. COPY OF - HST REGISTRATION (or blank remittance form)
5. COPY OF - OWNERSHIP (to verify RIN#)
6. COPY OF - VOID COMPANY CHEQUE
7. COPY OF - VALID INSURANCE
8. COPY OF- OMVIC REGISTRATION CERTIFICATE FOR EVERY AUTHORIZED REPRESENTATIVE
9. COPY OF - VALID DRIVER'S LICENCE
